FormaServe Systems is a leading provider of IBM i support, education and consultancy. Their staff have been working with IBM i since the announcement of the AS/400 in 1988. They are very active in the user group community such as i-UG and COMMON and promoting the platform through social media, newsletters, conference speaking and more. Their latest endeavor is helping their clients to adopt new technologies on IBM i such as open source.



Recently, the HM Revenue and Customs department in the United Kingdom has introduced a new policy called "Making Tax Digital". Initially focused on VAT reporting, companies are now required to automate their VAT reporting. The new policy will fully go into effect on April 1st, 2019. This is a new way of reporting business records for organizations within the United Kingdom, and will streamline the tax return process and reduce potential errors caused by human intervention.

FormaServe Systems built a new software solution for IBM i clients. Using RPG and the open source Node.js framework Express, the solution takes the tax values being tracked by most financial application packages, processes them, and securely transmits them to

the tax department. The software communicates with the HMRC servers to allow companies to track their liabilities and payments. FormaServe submitted their solution to the HM Revenue and Customs department for validation. The tax

IBM Customer Story - HMRC

- Making Tax Digital is a key part of the government's plans to make it easier for individuals & businesses to get their tax right & keep on top of their affairs
- Making Tax Digital is making fundamental changes to the way the tax system works transforming tax administration so that it is:
 - More effective
 - More efficient
 - Easier for taxpayers to get their tax right
- VAT registered businesses with a taxable turnover above the VAT threshold (£85k) are now required to use the Making Tax Digital service to keep records digitally & use software to submit their VAT Returns


IBM Customer Story - Us

Before software can be used to submit VAT returns, it has to be demonstrated to then approved by HMRC






